#### **Auctions:**

29 auctions with € 100 bn issuance volume and very strong demand (Ø b/o-ratio ~1.77)

- € 37 bn Bubills
- € 63 bn nominal bonds, thereof € 3 bn issued via Green Bonds:
  - Green multi-ISIN auction in January, € 1 bn tap of 30-year Green Bund (August 2053) and
    € 1 bn tap of 5-year Green Bobl (October 2027)
  - Green single auction in February, € 1 bn tap of 30-year Green Bund (August 2050)

#### **Syndicates:**

2 syndicates with € 10.5 bn issuance volume (€ 9 bn allocated, € 1.5 bn retention)

- New issue of 30-year conventional Bund (August 2054) on 30 January (€ 6 bn)
- Reopening of this 30-year conventional Bund on 5 March (€ 4.5 bn)
