## Ranking list of the Bund Issues Auction Group

In 2019 Federal Government securities (Federal bonds, Federal notes, Federal Treasury notes, Treasury discount paper and inflation-linked bonds) were issued in 77 auctions via the Bund Issues Auction Group.

The attached list shows the ranking of the 36 members of the Bund Issues Auction Group in 2019. The ranking is based on the allotted amounts in 2019, weighted by the respective duration and interest rate risk of the auctioned securities. The relevant weights were announced in December 2014.

The weighting factors will remain unchanged in 2020. The ranking will be published twice a year, towards the end of the months June and December.
