Invitation to bid Federal Treasury discount paper (Bubills)

As already announced the following Bubills will be reopened by a multi-ISIN auction on 14 November 2022:

Reopening Federal Treasury discount paper (Bubills) January 2022 issue / maturity 12 months ISIN DE0001030807 Current volume : € 21 billion Due on 18 January 2023 Residual maturity: 2 months (63 interest days)

Reopening Federal Treasury discount paper (Bubills) May 2022 issue / maturity 12 months ISIN DE0001030849 Current volume : € 9 billion Due on 17 May 2023 Residual maturity: 6 months (182 interest days)

A total amount of \in 5 billion is envisaged for the reopened Bubills (including respective retention quote) with a planned share of \in 2 billion for the Bubill January 2022 issue (ISIN DE0001030807) and \in 3 billion for the Bubill May 2022 issue (ISIN DE0001030849). The effective increase amount of each Bubill will be determined as part of the auction allotment on 14 November 2022.

Members of the Bund Issues Auction Group are entitled to bid. Bids must be for a par value of not less than € 1 million or an integral multiple thereof. The price bids must be expressed as full 0.00005 percentage points. It is possible to make non-competitive bids and to submit several bids at different prices. No yield bids will be considered. The bids accepted by the issuer will be allotted at the price specified in the bid. Non-competitive bids are filled at the weighted average price of the price bids accepted. The right to scale down bids is reserved.
