Announcement Federal Treasury discount paper (Bubills)

According to the issuance schedule of the German Federal Government for the first quarter of 2023 the following Bubills will be reopened by a multi-ISIN auction on 23 January 2023:

Reopening Federal Treasury discount paper (Bubills) April 2022 issue / maturity 12 months ISIN DE0001030831 Current volume : € 14 billion Due on 13 April 2023 Residual maturity: 3 months (78 interest days)

Reopening Federal Treasury discount paper (Bubills) October 2022 issue / maturity 12 months ISIN DE0001030898 Current volume : € 7 billion Due on 18 October 2023 Residual maturity: 9 months (266 interest days)

A total amount of \in 5 billion is envisaged for the reopened Bubills (including respective retention quote) with a planned share of \in 2 billion for the Bubill April 2022 issue (ISIN DE0001030831) and \in 3 billion for the Bubill October 2022 issue (ISIN DE0001030898). The effective increase amount of each Bubill will be determined as part of the auction allotment on 23 January 2023.

Members of the Bund Issues Auction Group are entitled to bid. Bids are to be submitted through the Bund Bidding System BBS and must be for a par value of not less than € 1 million or an integral multiple thereof. The price bids must be expressed in terms of full 0.00005 percentage points. Non-competitive bids are possible. The bids accepted by the issuer will be allotted at the price specified in the bid. Non-competitive bids are filled at the weighted average price of the bids accepted. The right to scale down bids is reserved.
