## Announcement of auction Reopening 10-year Federal bond

As already announced in the issuance calendar for the second quarter of 2023, the Federal Government will reopen once again the

## 2.30 % bond of the Federal Republic of Germany of 2023 (2033)

issued on 11 January 2023 - ISIN DE000BU2Z007

on 19 April 2023, using an auction procedure. An increase of  $\in$  4 billion is envisaged for the issue (auction allotment and retention quote). The current volume of the bond amounts to  $\notin$  20 billion. Members of the Bund Issues Auction Group are entitled to bid.
