Invitation to bid Federal Treasury discount paper (Bubills)

As already announced the following Bubills will be reopened by a multi-ISIN auction on 28 August 2023:

Reopening Federal Treasury discount paper (Bubills) January 2023 issue / maturity 12 months ISIN DE000BU0E014 Current volume : € 18 billion Due on 17 January 2024 Residual maturity: 5 months (140 interest days)

Reopening Federal Treasury discount paper (Bubills) July 2023 issue / maturity 12 months ISIN DE000BU0E071 Current volume : € 4 billion Due on 17 July 2024 Residual maturity: 11 months (322 interest days)

A total amount of \in 5 billion is envisaged for the reopened Bubills (including respective retention quote) with a planned share of \in 2 billion for the Bubill January 2023 issue (ISIN DE000BU0E014) and \in 3 billion for the Bubill July 2023 issue (ISIN DE000BU0E071). The effective increase amount of each Bubill will be determined as part of the auction allotment on 28 August 2023.

Members of the Bund Issues Auction Group are entitled to bid. Bids must be for a par value of not less than € 1 million or an integral multiple thereof. The price bids must be expressed as full 0.00005 percentage points. It is possible to submit non-competitive bids and several bids at different prices. No yield bids will be considered. The bids accepted by the issuer will be allotted at the price specified in the bid. Non-competitive bids are filled at the weighted average price of the price bids accepted. The right to scale down bids is reserved.
