Invitation to bid

Reopening of the 1.30 % five-year Green Federal notes ("Green Bobls") of 2022 (2027) Increase of the conventional 1.30 % five-year Federal notes series 186 of 2022 (2027)

For the account of the Federal Government, the German Finance Agency, through Deutsche Bundesbank, will reopen once again the

1.30 % five-year Green Federal notes of 2022 (2027) due on 15 October 2027 ISIN DE0001030740

launched on 31 August 2022, using an auction procedure. An increase of \in 1.5 billion is envisaged for the issue (auction allotment and amount set aside for secondary market operations). The current volume of the bond amounts to \in 6.5 billion.

Members of the Bund Issues Auction Group are entitled to bid. Bids must be for a par value of not less than \in 1 million or an integral multiple thereof. The price bids must be expressed in terms of full 0.01 percentage points. Non-competitive bids are possible. The bids accepted by the issuer will be allotted at the price specified in the bid. Non-competitive bids are filled at the weighted average price of the competitive bids accepted. The right to scale down bids is reserved.

Increase of the conventional 1.30 % five-year Federal notes series 186 of 2022 (2027)

On 30 August 2023, the outstanding volume of the conventional twin bond, the 1.30 % five-year Federal notes series 186 of 2022 (2027), due on 15 October 2027, ISIN DE0001141869, will be increased by \in 1.5 billion with effect from 1 September 2023. This increase will be added to the Federal Government's own holdings. The new outstanding volume of the conventional 1.30 % five-year Federal notes series 186 of 2022 (2027) will be \in 30 billion.
