## Invitation to bid Federal Treasury discount paper (Bubills)

As already announced the following Bubills will be reopened by a multi-ISIN auction on 30 October 2023:

Reopening Federal Treasury discount paper (Bubills) February 2023 issue / maturity 12 months ISIN DE000BU0E022 Current volume : € 19.5 billion Due on 21 February 2024 Residual maturity: 3 months (112 interest days)

Reopening Federal Treasury discount paper (Bubills) August 2023 issue / maturity 12 months ISIN DE000BU0E089 Current volume : € 7 billion Due on 21 August 2024 Residual maturity: 9 months (294 interest days)

A total amount of  $\in$  5 billion is envisaged for the reopened Bubills (including respective retention quote) with a planned share of  $\in$  3 billion for the Bubill February 2023 issue (ISIN DE000BU0E022) and  $\in$  2 billion for the Bubill August 2023 issue (ISIN DE000BU0E089). The effective increase amount of each Bubill will be determined as part of the auction allotment on 30 October 2023.

Members of the Bund Issues Auction Group are entitled to bid. Bids must be for a par value of not less than  $\in$  1 million or an integral multiple thereof. The yield bids must be expressed as full 0.001 percentage points. It is possible to submit non-competitive bids and several bids at different yields. No price bids will be considered. The bids accepted by the issuer will be allotted at the yield specified in the bid. Non-competitive bids are filled at the weighted average yield of the competitive bids accepted. The right to scale down bids is reserved.

Value date:	Wednesday, 1 November 2023
Settlement:	delivery versus payment-settlement in the night-time processing of Clearstream
