As already announced in the issuance calendar for the fourth quarter of 2023, the Federal Government will reopen the

3.10 % Federal Treasury notes of 2023 second issue (2025)

due on 12 December 2025 issued on 17 October 2023 - ISIN DE000BU22031

by auction on 14 November 2023. An increase of € 5 billion is envisaged for the issue (auction allotment and retention quote). The current volume amounts to € 5 billion. Members of the Bund Issues Auction Group are entitled to bid.
