## Announcement of a multi-ISIN auction Reopening of two Federal bonds

On 22 November 2023 the following Federal bonds will be reopened by a multi-ISIN auction:

0 % bond of the Federal Republic of Germany of 2020 (2035)

ISIN DE0001102515 Maturity: 15 May 2035

Current volume : € 23.25 billion

1 % bond of the Federal Republic of Germany of 2022 (2038)

ISIN DE0001102598 Maturity: 15 May 2038

Current volume : € 20.5 billion

An increase of € 1.5 billion in total is envisaged for the reopening of both bonds (including respective retention quote) with a planned share of € 0.5 billion for the 0 % bond of the Federal Republic of Germany of 2020 (2035), ISIN DE0001102515, and € 1 billion for the 1 % bond of the Federal Republic of Germany of 2022 (2038), ISIN DE0001102598. The effective increase of each bond will be determined by the allotment on 22 November 2023.

Members of the Bund Issues Auction Group are entitled to bid. Bids must be for a par value of not less than € 1 million or an integral multiple thereof. The price bids must be expressed in terms of full 0.01 percentage points. Non-competitive bids are possible. The bids accepted by the issuer will be allotted at the price specified in the bid. Non-competitive bids are filled at the weighted average price of the competitive bids accepted. The right to scale down bids is reserved.

Bidding period: Wednesday, 22 November 2023,

from 8.00 a.m. until 11.30 a.m. Frankfurt time

exchange trading: Wednesday, 22 November 2023
