Announcement of auction Reopening 10-year Federal bond

As already announced in the issuance calendar for the second quarter of 2025, the Federal Government will reopen once again the

2.50 % bond of the Federal Republic of Germany of 2025 (2035)

issued on 8 January 2025 - ISIN DE000BU2Z049

on 23 April 2025, using an auction procedure. An increase of € 4 billion is envisaged for the issue (auction allotment and retention quote). The current volume of the bond amounts to € 24 billion. Members of the Bund Issues Auction Group are entitled to bid.
