Auction announcement Reopening of five-year Federal notes (Bundesobligationen – “Bobl”) series 192 by auction

As already announced in the issue calendar for the third quarter of 2025, the Federal Government will reopen once again the

on 19 August 2025, using an auction procedure. An increase of € 4.5 billion is envisaged for the issue (auction allotment and retention quote). The current volume of this series amounts to € 9.5 billion. Members of the Bund Issues Auction Group are entitled to bid.
