Announcement of auction Reopening of Federal Treasury notes

As already announced in the issuance calendar for the third quarter of 2025, the Federal Government will reopen once again the

1.90 % Federal Treasury notes of 2025 (2027)
due on 16 September 2027
issued on 15 July 2025 - ISIN DE000BU22106

by auction on 23 September 2025. An increase of € 4.5 billion is envisaged for the issue (auction allotment and retention quote). The current volume amounts to € 14.5 billion. Members of the Bund Issues Auction Group are entitled to bid.
