# Announcement of auction Reopening 10-year Federal bond

As already announced in the issuance calendar for the fourth quarter of 2025, the Federal Government will reopen once again the

### **2.60 % bond of the Federal Republic of Germany of 2025 (2035)** issued on 2 July 2025 - ISIN DE000BU2Z056

on 1 October 2025, using an auction procedure. An increase of € 5 billion is envisaged for the issue (auction allotment and retention quote). The current volume of the bond amounts to € 21 billion. Members of the Bund Issues Auction Group are entitled to bid.

Maturity:	15 August 2035
Interest payment:	15 August annually, interest has begun to accrue on 4 July 2025
First interest payment:	15 August 2026 for 407 days
