Announcement of auction Reopening of Federal Treasury notes

As already announced in the issuance calendar for the fourth quarter of 2025, the Federal Government will reopen the

2 % Federal Treasury notes of 2025 (2027)

due on 16 December 2027 issued on 14 October 2025 - ISIN DE000BU22114

by auction on 4 November 2025. An increase of € 5 billion is envisaged for the issue (auction allotment and retention quote). The current volume amounts to € 5.5 billion. Members of the Bund Issues Auction Group are entitled to bid.

Publication of invitation to bid: Monday, 3 November 2025

Bidding period: Tuesday, 4 November 2025,

from 8.00 a.m. until 11.30 a.m. Frankfurt time

exchange trading: Tuesday, 4 November 2025

Characteristics of the Federal Treasury notes:

Maturity: 16 December 2027

Interest has begun to accrue on: 16 October 2025

Interest payment: annually on 16 December,

first interest payment on 16 December 2026 for 426 days
