Announcement of auction Reopening 10-year Federal bond

As already announced in the issuance calendar for the first quarter of 2026, the Federal Government will reopen once again the

2.90 % bond of the Federal Republic of Germany of 2026 (2036)
issued on 7 January 2026 - ISIN DE000BU2Z064

on 11 March 2026, using an auction procedure. An increase of € 5 billion is envisaged for the issue (auction allotment and retention quote). The current volume of the bond amounts to € 17.5 billion. Members of the Bund Issues Auction Group are entitled to bid.
